A PROPOSED RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO CALTEX GAS STATION FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE FILLING STATION TO BE LOCATED AT NO. 49 SCOUT ALCARAZ STREET, CORNER D. TUAZON STREET, STA. MESA HEIGHTS, BARANGAY MAHARLIKA, QUEZON CITY.

WHEREAS, petitioner, Caltex Gas Station, a business entity duly registered under Philippine laws is applying for a Special Use Permit (SUP) to be used for the construction and operation of a Gasoline Filling Station located at No. 49 Scout Alcaraz Street corner D. Tuazon Street, Sta. Mesa Heights, Barangay Maharlika Quezon City;

WHEREAS, fuel stations are among the uses that require a Special Use Permit upon authorization from the Quezon City Council as provided in Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance as amended;

WHEREAS, Caltex Gas Station, has complied with the necessary requirements for the issuance of a Special Use Permit as mandated by the Quezon City Comprehensive Zoning Ordinance;
