RESOLUTION NO. SP- 5620, S-2012

A RESOLUTION DIRECTING THE QUEZON CITY PARKS DEVELOPMENT AND ADMINISTRATION DEPARTMENT (PDAD) TO CHECK THE LEAD CONTENT OF ALL EQUIPMENT AT THE QUEZON CITY MEMORIAL CIRCLE AND IN OTHER PARKS IN QUEZON CITY AND TO REPLACE AND REPAIR ALL THE EQUIPMENT THAT DO NOT PASS THE ALLOWABLE LEAD CONTENT TO 90 PPM.

WHEREAS, the Quezon City Government is mandated to formulate legislative measures which aim to promote and protect the welfare of its constituency;

WHEREAS, it was observed that there are playground equipment at the Quezon City Memorial Circle and in other parks in Quezon City with a lead content of 100,000 ppm;

WHEREAS, based on U.S. study the allowable lead content limit is only 90 ppm.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to direct, as it does hereby direct the Quezon City Parks Development and Administration Department (PDAD) to check the lead content of all equipment at the Quezon City Memorial Circle and in other parks in Quezon City and to replace and repair all the equipment that do not pass the allowable lead content to 90 ppm.
