WHEREAS, petitioner Jetti Petroleum Inc., a business entity duly registered under Philippine Laws, is applying for a Special Use Permit (SUP) to be used for the construction and operation of a Gasoline Filling Station located at No. 607 Quirino Highway, Barangay Bagbag, Quezon City;

WHEREAS, fuel stations are among the users that require a Special Use Permit upon authorization from the Quezon City Council as provided in Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2000, as amended;

WHEREAS, Jetti Petroleum Inc. has complied with the necessary requirements for the issuance of a Special Use Permit as mandated by the Quezon City Comprehensive Zoning Ordinance;

WHEREAS, the construction and operation of a gas station will provide employment and promote economic development in the City.
