A RESOLUTION URGING THE HONORABLE VICE MAYOR TO SEEK OFFICIAL CLASS TIME FOR ALL SANGGUNIANG KABATAAN CHAIRPERSONS DURING CITY BUDGET DELIBERATIONS.

WHEREAS, Title V of Republic Act No. 7160 or The Local Government Code, provides the fundamental principles and provisions for the fiscal administration of the City, and under Section 319 thereof, the Sangguniang Panglungsod authorizes and legislates the City Budget, composed of the budget requirements and proposals of all departments, schools and barangays of this City;

WHEREAS, under Sections 426 and 431 of the Local Government Code, the Sangguniang Kabataan (SK) and its Chair have the duty to participate in the determination and articulation of, among others, the economic, political and administrative needs of the youth in their respective barangays;

WHEREAS, the Honorable Sangguniang Panglungsod has consistently consulted all offices and sectors, including involving youth leaders in the determination of the budgetary needs of the City, and these take place usually during working and school days;

WHEREAS, the presence of SK Chairs are indispensable to such budget deliberations, and their attendance thereof intensifies their involvement in their self-determination and grooms them to take on future roles of leadership for the City, hence there is a need to intervene and seek the approval of their attendance in budget deliberations with clearance from their respective schools.

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge the Presiding Officer of the Sangguniang Panglungsod, no less than the Honorable Vice-Mayor, Josefina Belmonte-Alimurung, to seek official class time for all Sangguninag Kabataan Chairpersons of this City, from their respective school deans and principals, for purposes of assuring their attendance and commitment to the legislation of the City's annual and supplemental budgets.

RESOLVED, FURTHER, that copies of this Resolution be furnished the Office of the City Vice-Mayor, the various barangays, the press and other concerned offices for their information and guidance.
