A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ACCEPT FOR AND IN BEHALF OF THE QUEZON CITY GOVERNMENT THE DONATION MADE BY MR. ROBERT A. LEUNG, COVERING THE ROAD LOT EMBRACED UNDER TRANSFER CERTIFICATE OF TITLE NO. 004-2012011875 OF THE REGISTRY OF DEEDS OF QUEZON CITY.

WHEREAS, the donation is not made with the object of defrauding his creditors contracted prior to the acceptance of the Deed of Donation;



Leung, covering the road lot embraced under Transfer Certificate of Title No. 004-2012011875 of the Registry of Deeds of Quezon City.
