A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE TWO (2) UNITS OF MOTOR VEHICLES FOR THE OFFICIAL USE OF THE OFFICE OF COUNCILOR RODERICK M. PAULATE.

WHEREAS, under Section 2, Article I of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, it is the policy of the State to promote the ideals of good governance in all its branches, departments, agencies, subdivisions and instrumentalities including government-owned and controlled corporations and local government units;

WHEREAS, Section 455 (1) (vi) of Republic Act No. 7160, also known as the Local Government Code of 1991, provides that the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the sangguniang panlungsod or pursuant to law or ordinance;

WHEREAS, to ensure the expeditious delivery of quality public service and to make the members of the City Council more closer to its constituents through monitoring of projects and immersion programs, there is an imperative need to provide them the necessary motor vehicles;

WHEREAS, Councilor Roderick M. Paulate is desiring to procure two (2) units of fourteen-seater van to be used for the aforesaid purposes, specifically described hereunder:

“Euro II Engine, 2.5 liter, Diesel Engine, 4 cylinder in line SOHC fuel injected engine, power steering, 5 speed column shift Manual transmission: 72 horsepower, 4,200 RPM: GVW 2,205 kgs. Body and paload 1140kgs 5 pcs. 5.0J x 14” steel rims with 185 SRI x 14:8 PRT tires: front seat belts; analog clock; stereo; Power steering; 8 DIP zero rust paint process With 3 years anti-rust warranty”

WHEREAS, in a letter dated May 22, 2012 of DILG City Director, Juan Jovian E. Ingeniero, addressed to his Honor, Mayor Herbert M. Bautista, he underscored the need for an approved resolution of the City Council authorizing the City Mayor to purchase service motor vehicles for the use of any department/office under the Quezon City Government.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to purchase two (2) units of motor vehicles for the official use of the Office of Councilor Roderick M. Paulate.

RESOLVED, FURTHER, that the budget to be utilized for the purchase of the subject motor vehicles shall be charged to the funds earmarked or allocated to the Office of Councilor Paulate.
