A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO PETRON GAS STATION FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE FILLING STATION TO BE LOCATED AT BLOCK 176, LOT 16 DON MARIANO MARCOS AVENUE, NORTH FAIRVIEW, DISTRICT II, QUEZON CITY.

WHEREAS, petitioner Petron Gas Station, a business entity duly registered under Philippine laws, is applying for a Special Use Permit (SUP) to be used for the construction and operation of a Gasoline Filling Station located at Block 176, Lot 16, Don Mariano Marcos Avenue, North Fairview, District II, Quezon City;

WHEREAS, fuel stations are among the uses that require a Special Use Permit upon authorization from the Quezon City Council as provided in Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2000;

WHEREAS, Petron Gas Station has complied with the necessary requirements for the issuance of a Special Use Permit as mandated by the Quezon City Comprehensive Zoning Ordinance;

WHEREAS, the construction and operation of a Gasoline Filling Station will provide employment and promote economic development in the City.
