*WHEREAS, under Title Four, Section 98 (a) of the Local Government Code of 1991, "there shall be established in every city a city school board composed of the City Mayor and the City Superintendent of schools as co-chairman; the chairman of the education committee of the Sangguniang Panlungsod, the City Treasurer, the representative of the Pederasyon ng mga Sangguniang Kabataan in the Sangguniang Panlungsod, the duly elected president of the city federation of Parents-Teacher's Association, the duly elected representative of the teacher's organization in the city, and the duly elected representative of the non-academic personnel of public schools in the city, as member";*

*WHEREAS, the performance of the duties and responsibilities of the above-mentioned officials in their respective local schools boards shall not be delegated;*

*WHEREAS, principals in every schools are mandated to perform the functions as Head of a school and from time to time coordinate with the school board on matters affecting their schools;*


*WHEREAS, there are identified priority projects in the schools agenda that need to be steered through the process which required close coordination and liaison between the school and the school board;*
