RESOLUTION NO. SP- 5683 , S-2013

A RESOLUTION AMENDING RESOLUTION NO. SP-5645, S-2012, AUTHORIZING THE PURCHASE BY THE QUEZON CITY GOVERNMENT, THROUGH THE OFFICE OF THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, OF ONE (1) UNIT OF MOTOR VEHICLE INTENDED FOR MONITORING OF PROGRAMS AND PROJECTS OF SAID OFFICE, AMOUNTING TO SIX HUNDRED SEVENTY SEVEN THOUSAND SEVEN HUNDRED TWO PESOS AND EIGHTEEN CENTAVOS (PHP677, 702.18) TO BE CHARGED TO THE OFFICE OF COUNCILOR ALFREDO PAOLO D. VARGAS.

Bautista has already sought permission and authorization from DILG in his letter addressed to Secretary Jessie Robredo of DILG for the acquisition of the above-described motor vehicle amounting to P677,702.18 which amount is included in the 2012 Annual Budget of the City Government under the City Council, Quezon City;

WHEREAS, pursuant to Section 455 (b) (1) (vi) of Republic Act No. 7160, otherwise known as the "Local Government Act of 1991", the City Mayor shall represent the City in all its transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to amend, as it does hereby amend Resolution No. 5645, S-2012, authorizing the purchase by the Quezon City Government, through the Office of the City Mayor, Honorable Herbert M. Bautista, of one (1) unit of motor vehicle intended for monitoring of programs and projects of said office, amounting to Six Hundred Seventy Seven Thousand Seven Hundred Two Pesos and Eighteen Centavos (Php677,702.18) to be charged to the Office of Councilor Alfredo Paolo D. Vargas.
