RESOLUTION NO. SP- 5685, S-2013.

**A RESOLUTION AUTHORIZING THE PURCHASE BY THE QUEZON CITY GOVERNMENT, THROUGH THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, OF THREE (3) UNITS OF MOTOR VEHICLE AMOUNTING TO TWO MILLION EIGHT HUNDRED SEVENTEEN THOUSAND PESOS (PHP 2,817,000.00), TO BE CHARGED AGAINST THE FUNDS OF THE OFFICE OF COUNCILOR JOSE MARIO DON S. DE LEON INTENDED FOR MONITORING OF PROGRAMS AND PROJECTS OF THE LATTER'S OFFICE.**


*NOW, THEREFORE,*
