
A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE VICTIMS OF FIRE THAT OCCURRED ON MARCH 1, 2013 AT AREA 5 NAMALU HOA, LUZON AVENUE, BARANGAY MATANDANG BALARA, DISTRICT III, QUEZON CITY IN THE AMOUNT OF TWO THOUSAND PESOS (P2,000.00) PER FAMILY OWNER AND ONE THOUSAND PESOS (P1,000.00) PER FAMILY RENTER/SHARER WHICH SHALL BE TAKEN FROM THE CALAMITY OR EMERGENCY FUND OR FROM ANY AVAILABLE FUNDS OF THE CITY GOVERNMENT.

Introduced by Councilors JOSE MARIO DON S. DE LEON, JULIAN ML. COSETENG, ALLAN BENEDICT S. REYES, JAIME F. BORRES, GIAN CARLO G. SOTTO and EUFEMIO C. LAGUMBAY.

WHEREAS, on March 1, 2013, a fire occurred at Area 5 Namalu Hoa, Luzon Avenue, Barangay Matandang Balara, District III, Quezon City, a densely populated area, burning houses that rendered several families homeless;

WHEREAS, because of this calamity, the victims are experiencing grief and anxiety, and the problem of building a new house to live in;

WHEREAS, in order to lessen the difficulty and uplift the plight of the fire victims, it is hereby deemed proper to extend financial assistance.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant financial assistance to the victims of fire that occurred on March 1, 2013 at Area 5 Luzon Avenue, Barangay Matandang Balara, District III, Quezon City, in the amount of two thousand pesos (P2,000.00) per family owner and one thousand pesos (P1,000.00) per family renter/sharer, to be taken from the Calamity or Emergency Fund or from any available funds of the City Government.

RESOLVED, FURTHER, that the exact numbers and identities of the fire victims shall be determined by the Social Services and Development Department. The Department shall process the necessary documents needed for the financial assistance granted under this Resolution.
