RESOLUTION NO. SP- 5714 , S-2013

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO C.U.L. TRANSPORT FOR THE CONSTRUCTION AND OPERATION OF A TRANSPORT TERMINAL/BUS GARAGE LOCATED AT NO. LOT 2 A, B, C LILAC STREET CORNER NARCISSUS STREET, WEST FAIRVIEW, BARANGAY FAIRVIEW, DISTRICT II, QUEZON CITY.

WHEREAS, having complied with the requirements as set forth by law, Resolution No. SB – 04-001, S-2012 of the Sangguniang Barangay of Barangay Fairview attests that the said barangay interposes no objection to the said project;

WHEREAS, in accordance with the provisions of Article VII, Section 2 of Ordinance No. SP-918, S-2000 and its Implementing Rules and Regulations, a Special Use Permit is required for the said project;

WHEREAS, the petitioner has complied with and is further ready, able and willing to comply with all the prescribed requirements relative to their application for the issuance of a Special Use Permit.
