RESOLUTION NO. SP- 5720, S-2013

A RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT (LGU-QC), REPRESENTED BY THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT, REPRESENTED BY ITS SECRETARY, HONORABLE CORAZON "DINKY" SOLIMAN, AND HONORABLE JORGE B. BANAL, JR., REPRESENTATIVE OF THE 3RD CONGRESSIONAL DISTRICT OF QUEZON CITY, FOR THE DEVELOPMENT OF ON-SITE SOCIALIZED HOUSING PROJECT FOR PERSONS WITH DISABILITIES (PWDs) RESIDING INSIDE THE NATIONAL VOCATIONAL REHABILITATION CENTER (NVRC) COMPOUND AND WIDENING OF MAPAGMAHAL STREET IN BARANGAY ESCOPA III, PROJECT 4, QUEZON CITY.

WHEREAS, Presidential Proclamation No. 504, Series of 2003 has excluded a parcel of land described as Lot No. 7-F, Sub-Block No. 13-F, Psd-473, containing an area of Thirty One Thousand Seven Hundred Seventy Seven (31,777) Square Meters, more or less, from the coverage area of Presidential Proclamation No. 6, Series of 2001, and reserving the same for Rehabilitation Center purposes of the People with Disabilities (PWDs) under the supervision and administration of the Department of Social Welfare and Development (DSWD);

WHEREAS, the above-described parcel of land is the present site of the National Vocational Rehabilitation Center (NVRC);

WHEREAS, the LGU-QC constituted a Task Force on Socialized Housing and Development of Blighted Areas pursuant to Local Executive Order No. 6, Series of 2010, whose primary objectives are the transformation of blighted areas into decent communities through development of socialized housing, by partnering and venturing necessary and appropriate assistance to affected families;

WHEREAS, the LGU-QC created a Special Task Force Escopa (STF Escopa), composed of its line agencies, Office of the Representative of the 3rd Congressional District of Quezon City and Barangay Councils of Escopa I, II, III, IV, to assist and facilitate the implementation of developments in Escopa;

WHEREAS, the overall development of Escopa includes the proposed development of On-Site Housing Project for PWDs and the widening/road improvement of the main road of the four (4) barangays;

WHEREAS, the DSWD has agreed to the proposal of the LGU-QC to develop an on-site housing project for PWDs;

WHEREAS, the DSWD has also agreed to allow the LGU-QC to widen Mapagmahal Street;

WHEREAS, a Memorandum of Agreement (MOA) was made and entered into by and between the DSWD, LGU-QC and HONORABLE JORGE B. BANAL, JR., for the development of the aforementioned projects.


