RESOLUTION NO. SP- 5723, S-2013

A RESOLUTION RESPECTFULLY REQUESTING HIS HONOR, SPEAKER FELICIANO "SB" BELMONTE, JR., TO ALLOCATE FUND FOR THE CONSTRUCTION OF THE 2ND FLOOR OF A ONE (1)-STOREY STRUCTURE MEASURING 3.38 METERS BY 15.38 METERS OR A TOTAL FLOOR AREA OF 76.64 SQUARE METERS TO BE UTILIZED AS BARANGAY HEALTH CENTER OFFICE LOCATED AT BROADWAY STREET, BARANGAY KALUSUGAN, AREA 21, DISTRICT IV, QUEZON CITY.
