**A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO SELL ONE (1) MOTOR VEHICLE ASSIGNED TO COUNCILOR AFREDO D. VARGAS III, THE PRICE OF WHICH IS TO BE DETERMINED BY THE CITY APPRAISAL COMMITTEE SUBJECT TO AUDITING RULES AND REGULATIONS.**

ENGINE NUMBER : 4D56UCDN1530


WHEREAS, Councilor Vargas manifested his intention to purchase the aforementioned vehicle, due to the reason that the subject vehicle has a sentimental value to him;


