RESOLUTION NO. SP- 5746, S-2013.

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO EXTEND THE SECURITY SERVICE CONTRACTS OF LOCKHEED DETECTIVE AND WATCHMAN AGENCY, INC., MARBAN SECURITY AND INVESTIGATION AGENCY, INC. AND MICA SECURITY AGENCY, INC. FOR SIX (6) MONTHS, FROM FEBRUARY 1, 2013 TO JULY 31, 2013.

WHEREAS, the Quezon City Government has an existing security service contracts with Lockheed Detective and Watchman Agency, Inc., Marban Security and Investigation Agency, Inc. and Mica Security Agency, Inc. to guard and protect the Quezon City Government premises and properties;

WHEREAS, the security service contracts of Quezon City Government with the said service providers had terminated on January 31, 2013;

WHEREAS, the Quezon City Bids and Awards Committee (QC-BAC) issued a Resolution No. 13-002E, Series of 2013 entitled "Recommending to and for the approval by the City Mayor with the extension of the Security Service Contracts with the service providers";

WHEREAS, the Quezon City General Services Department (QC-GSD), the end-user of the project, requested to the Office of the City Mayor that the existing security service contracts with Lockheed Detective and Watchman Agency, Inc., Marban Security and Investigation Agency, Inc. and Mica Security Agency, Inc. be extended for six (6) months from February 1, 2013 to July 31, 2013 to review, evaluate and incorporate in the proposed terms of reference for the project:

AS DS


- a. *The mandatory provisions on Close Circuit Television (CCTV) in strategic areas in all government installations covered by the contract;*
- b. *The security deployment for recovered property such as the Community Development Center in Barangay NS Amoranto, and the deployment of security guards in Carlos Albert High School, City Library in Project 8 and additional security for the Quezon Memorial Circle;*

WHEREAS, the request for extension is further prompted by the upcoming election where election ban would be implemented forty-five (45) days before and after election on May 13, 2013.


NOW, THEREFORE,


