**A RESOLUTION URGING MAYNILAD TO PROVIDE WATER CONNECTION TO RESIDENTS OF AREA I AND AREA III, SITIO VETERANS, BARANGAY BAGONG SILANGAN, QUEZON CITY, CONSISTENT WITH THE GENERAL WELFARE CLAUSE OF THE CONSTITUTION.**

*WHEREAS, the Local Government Code of 1991 (Republic Act No. 7160) accords every local government unit power and authority to promote the general welfare within its territorial jurisdiction,*

*WHEREAS, the City Council is mandated to formulate legislative measures to promote the welfare of its constituency,*

*WHEREAS, Sitio Veterans is an area in Bagong Silangan wherein many of the households are not yet served by Maynilad;*

*WHEREAS, Sitio Veterans is densely populated and does not have its own water facilities;*

*BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge Maynilad to provide water connections to residents of Area I and Area III, Sitio Veterans, Barangay Bagong Silangan, Quezon City, consistent with the general welfare clause of the constitution.*
