A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO SIGN AND ACCEPT THE DEED OF DONATION AND ACCEPTANCE BY JANUARIO B. REYES, REPRESENTED BY HIS ATTORNEY-IN-FACT, NORBERTO S. REYES, FOR AN ALLEY DESCRIBED AS LOT 4547-J, (LRC) PSD-319161 COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 318188 OF THE REGISTRY OF DEEDS OF QUEZON CITY CONTAINING AN AREA OF ONE HUNDRED SIXTY ONE (161) SQUARE METERS LOCATED ALONG ANICETA STREET, BARANGAY APOLONIO SAMSON, QUEZON CITY.


