RESOLUTION NO. SP- 5855, S-2014

A RESOLUTION EXPRESSING THE ACCEPTANCE OF THE QUEZON CITY GOVERNMENT TO THE EARNEST DESIRE OF THE SANGGUNIANG BAYAN OF BALER, PROVINCE OF AURORA, TO ESTABLISH A SISTERHOOD OR TWINNING RELATIONSHIP.

WHEREAS, the Sangguniang Bayan of Baler, Province of Aurora, unanimously adopted a Resolution No. 055-2013 dated 7 August 2013, expressing their intent to establish a sisterhood or twinning relationship with Quezon City;

WHEREAS, the Municipality of Baler, where President Manuel L. Quezon was born, intends to establish sisterhood agreement with the City to create a bonding tie that will foster closer relationship among its people and boost social and cultural exchanges and economic ties between the two LGUs;

WHEREAS, the sisterhood pact between and among the two local government units will create mutual cooperation to pursue and attain its common objective which is the promotion of general welfare for its respective constituents through the exchange of ideas and technology and adoption of tradition and practices beneficial to both;

WHEREAS, the newly elected Municipal Mayor and the Sangguniang Bayan together with the private sector and the entire town of Baler are eagerly anticipating this sister-city partnership;

WHEREAS, the Municipality of Baler, Province of Aurora has complied with Quezon City Ordinance No. SP-2107, S-2011 entitled "An Ordinance Establishing Guidelines For Sister City Or Twinning Relations Between Quezon City, Other Cities And Municipalities";

WHEREAS, it is fitting to establish sisterhood relationship with the Municipal Government of Baler, Province of Aurora since the two local government units shared common idea and that is to maintain good and effective local governance to enhance socio-economic development within its territory and in loving memory of the late President Manuel L. Quezon to whom Baler and Quezon City are bound together by historical ties.

NOW. THEREFORE

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to express, as it does hereby express the acceptance of the Quezon City Government to the earnest desire of the Sangguniang Bayan of Baler, Province of Aurora, to establish a sisterhood or twinning relationship.

RESOLVED, FURTHER, that a copy of this Resolution be forwarded to the Honorable City Mayor for information and appropriate action.
