WHEREAS, by virtue of Resolution No. SP-5750, S-2013, the City Mayor, Honorable Herbert M. Bautista, was authorized to sign in the Memorandum of Agreement (MOA) entered into by and between the Quezon City Government and Habitat for Humanity Philippines Foundation, Inc. (HABITAT), for the development of Socialized Housing Project Bistekville-4 in Barangay Culiat, Quezon City:

WHEREAS, the project aims to provide affordable and decent housing units for the actual occupants of the property and other informal settlers in Quezon City who will be selected, screened pre-qualified and agreed upon by the parties in the MOA;

WHEREAS, the Project Site is an expropriated property of the Quezon City Government consisting of Nine Thousand Two Hundred (9,200) Square Meters, and more particularly described as Lot 644-A-7-D, Psd-32232, covered by Transfer Certificate of Title No. RT-61967 (112582), situated in Barangay Culiat, Quezon City;

WHEREAS, the project comprises of complete land development and construction of Sixty Eight (68) units of one-storey rowhouses with loft and One Hundred Fifty (150) units of two-storey walk-up rowhouses;

WHEREAS, the proponents of the project are Quezon City Government as land owner and land developer, Habitat as housing developer, HDMF as financer, and qualified Quezon City Informal Settlers as beneficiaries;

WHEREAS, a copy of the Memorandum of Agreement (MOA) and City Council Resolution No. SP-5750, S-2013 is hereto attached and made an integral part of this resolution.

Ayco, for the development of Socialized Housing Project Bistekville-4 in Barangay Culiat, Quezon City.
