RESOLUTION NO. SP- 5865, S-2014

A RESOLUTION GRANTING A SPECIAL PERMIT TO THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR) TO OPERATE AN E-GAMES STATION THROUGH AN ACCREDITED E-GAMES OPERATOR BY IDOT GAME CORPORATION AT 2ND FLOOR CITIGOLD PLAZA, KATIPUNAN AVENUE, BARANGAY BAYANIHAN, QUEZON CITY.

WHEREAS, the Philippine Amusement and Gaming Corporation (PAGCOR), a duly constituted/registered entity, is applying for a Special Permit from the City Council as a requirement for the issuance of business permit pursuant to Resolution No. SP-3153, S-2005;

WHEREAS, the applicant is authorized to operate an accredited E-games Station, through an accredited E-games operator, pursuant to and as covered under the provisions of Presidential Decree No. 1869;

WHEREAS, a special permit was granted with the approval of Resolution No. SP 3915, S-2007 which has now expired;

WHEREAS, the applicant is applying to operate an E-games Station at 2nd Floor Citigold Plaza, Katipunan Avenue, Barangay Bayanihan, Quezon City;

WHEREAS, the applicant has complied with the pertinent requirements in securing a Business Permit in Quezon City. X


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant a Special Permit to Philippine Amusement and Gaming Corporation (PAGCOR) to operate an E-games Station through an accredited e-games operator by IDOT Game Corporation at 2nd Floor Citigold Plaza, Katipunan Avenue, Barangay Bayanihan, Quezon City.

RESOLVED, FURTHER, that the Philippine Amusement and Gaming Corporation (PAGCOR) shall remit to the City Treasurer in lieu of all business taxes, a franchise fee of three percent (3%) of the gross revenue of herein grantee, which shall be made payable yearly to the City Treasurer during the lifetime of this measure.

RESOLVED, FINALLY, that the authority herein granted shall be for a period of two (2) years and maybe renewed by the City Council.


