A RESOLUTION AUTHORIZING THE CITY MAYOR OF QUEZON CITY, HONORABLE HERBERT M. BAUTISTA, TO ENTER INTO A DEED OF DONATION WITH THE DEL-NACIA CORPORATION BY ACCEPTING THE DONATION MADE BY THE LATTER CORPORATION IN FAVOR OF THE CITY GOVERNMENT RELATIVE TO THE TWO (2) EASEMENT LOTS, THIRTEEN (13) ROAD LOTS AND ONE (1) OPEN SPACE LOCATED AT DEL-NACIA VILLE NUMBER 4, BARANGAY SAUYO, TANDANG SORA, QUEZON CITY, SUBJECT TO THE PAYMENT OF REAL PROPERTY TAXES UP TO 2013.
