**WHEREAS, the said vehicle has been assigned to Honorable Donato C. Matias, Councilor, District 6. It has been in his possession and use since 2004 when he served as the Officer-in-Charge of the Quezon City Barangay Operations Center and in 2009 when he assumed the position as the City Market Administrator;**
