A RESOLUTION AUTHORIZING THE CITY MAYOR HONORABLE HERBERT M. BAUTISTA, TO PURCHASE ONE (1) UNIT OF MOTOR VEHICLE IN THE AMOUNT OF SEVEN HUNDRED TWENTY THOUSAND PESOS (PHP720,000.00) TO BE TAKEN FROM THE FUNDS OF THE OFFICE OF THE CITY MAYOR, INTENDED FOR MONITORING OF VARIOUS PROGRAMS AND PROJECTS OF THE OFFICE OF THE CITY TREASURER.
