**RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO BALIWAG TRANSIT INC. FOR THE OPERATION OF A BUS TERMINAL STATION LOCATED ALONG EDSA, BARANGAY E. RODRIGUEZ SR., CUBAO, QUEZON CITY.**

*WHEREAS* petitioner Baliwag Transport Inc., a duly registered business entity under Philippine law is applying for the issuance of a Special Use Permit (SUP) for the operation of a bus terminal station located along EDSA, Barangay E. Rodriguez Sr., Cubao, Quezon City;

*WHEREAS* the proposed development will be a one (1) storey bus terminal with office and have its own drop-off/pick-up area inside the compound and alternate exit along Montreal Street;

*WHEREAS* Transport Terminal are among the uses which require a Special Use Permit upon authorization from the Quezon City Council as provided in Ordinance no. No. SP-2200, S-2013, otherwise known as the Revised Quezon City Comprehensive Zoning Ordinance;

*WHEREAS* Baliwag Transport, Inc. has complied with the requirements for the issuance of a Special Use Permit as required by said Ordinance;

*WHEREAS, the operation of a transport garage will promote public welfare and for the development of our economy as well as for the increase of employment in our city;*

*WHEREAS, the proposed project will not adversely affect public health, safety and welfare and the appropriate use of the adjoining property, and it will also provide and promote livelihood.*

**NOW, THEREFORE,**

**BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED,** to authorize, as it does hereby authorize the issuance of a Special Use Permit to Baltiwag Transit, Inc. for the operation of a bus terminal with diesel refilling station located along EDSA, Barangay E. Rodriguez Sr., Cubao, Quezon City


**RESOLVED, FURTHER,** that the Special Use Permit shall be automatically revoked in case the LTFRB revoked the franchise.

**RESOLVED, FINALLY,** that only buses of the Company with appropriate body markings shall use the terminal.
