RESOLUTION NO. SP- 5915, S-2014

**A RESOLUTION AUTHORIZING THE PURCHASE BY QUEZON CITY GOVERNMENT, THROUGH THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, OF THREE (3) UNITS OF MOTOR VEHICLES AMOUNTING TO TWO MILLION EIGHT HUNDRED EIGHTY SEVEN THOUSAND NINE HUNDRED FORTY FOUR PESOS AND SIXTY SIX CENTAVOS (P2,887,944.66), TO BE CHARGED AGAINST THE FUNDS OF THE OFFICE OF THE CITY MAYOR INTENDED FOR CLEARING AND DISMANTLING OPERATIONS AS WELL AS FOR MONITORING OF PROGRAMS AND PROJECTS UNDER THE TASK FORCE COMMONWEALTH.**

*WHEREAS, the Task Force Commonwealth under the Office of the City Mayor Honorable Herbert M. Bautista, through the Secretary to the Mayor, Mr. Tadeo M. Palma has requested for the purchase of three (3) units of motor vehicles, which will be used for clearing and dismantling operations as well as for monitoring of programs and projects under Task Force Commonwealth;*

*WHEREAS, the specifications and general descriptions of the three (3) motor vehicles shall be as follows;*

**AUV CAB CHASSIS DE LUXE (1 UNIT)**

- 4D56 SOHC 2.5 Diesel Euro Engine, 5 Speed Manual Transmission
- Warranty is for 3 years or 100,000 kms.
- Whichever comes first

- 4D56 SOHC 2.5 L Diesel Euro II Compliant Engine, 5 Speed Manual Transmission with optional body
- *FEATURES: rounded roof corners, rounded corner posts, gutterless roof, recessed sliding windows, re-countoured side panels, spray-on rhino-lining on side and flooring, moulded plastic, new front grille design, new halogen head lamp and new stereo design trims on front panel and back door lock mechanism for rear door.*
- *Warranty is 3 years or 100,000 kms.*


**NOW, THEREFORE,**
