RESOLUTION NO. SP- 5916 S-2014

**A RESOLUTION AUTHORIZING THE PURCHASE BY QUEZON CITY GOVERNMENT, THROUGH THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, OF ONE (1) UNIT OF MOTOR VEHICLE AMOUNTING TO SEVEN HUNDRED TWELVE THOUSAND FOUR HUNDRED FORTY SEVEN PESOS (P712,447.00) TO BE CHARGED AGAINST THE FUNDS OF THE OFFICE OF THE CITY MAYOR TO BE DONATED TO BARANGAY GAYA-GAYA, SAN JOSE DEL MONTE, RELOCATION SITE OF QUEZON CITY RESIDENTS LIVING IN DANGER ZONES.**

**WHEREAS, the Barangay Council of Barangay Gaya-Gaya, San Jose Del Monte, Bulacan through a Barangay Resolution No.13-08-106, requested Mayor Herbert M. Bautista for a barangay service vehicle;**

**WHEREAS, Barangay Gaya-Gaya serves as relocation site of Quezon City residents living in danger zones;**

**WHEREAS, the Office of the City Mayor through the Secretary to the Mayor, Mr. Tadeo M. Palma has requested the 19<sup>th</sup> City Council for the authority to purchase of one (1) unit of motor vehicle, to be donated to the said barangay;**

**WHEREAS, the specifications and general descriptions of the motor vehicle shall be as follows;**

**AUV With Dual Aircon, with a prove 4D56 SOHC 2.5 L Diesel-EURO II complaint engine, 5 Speed Manual Transmission with Optional Body.**

**Features: Rounded roof corners, rounded corner posts, Gutterless roof, recessed sliding windows, Re-countoured side panels, Spray-on-Rhino-Lining on side and Flooring, moulded plastic, New Front Grille Design, New Hallogen Head Lamp and New Stereo Design, Trims on front panel and back door, door lock mechanism for rear door.**


*Warranty is for 3 years or 100,000 KMS  
Whichever comes first.*

*WHEREAS, Section 455 (b) (1) (vi) of Republic Act. No. 7160, otherwise known as the "Local Government Code of 1991", provides that the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.*


**NOW, THEREFORE,**


