A RESOLUTION REQUESTING THE QUEZON CITY GOVERNMENT TO FACILITATE THE INSTALLATION OR CONSTRUCTION OF A "WELCOME ARCH" IN TEN (10) MAJOR ENTRY POINTS OF QUEZON CITY BEARING THE STATEMENT "WELCOME TO QUEZON CITY, THE CITY OF STARS".

WHEREAS, on October 6, 1998 the City Council of Quezon City, through the effort of then City Councilor Fernando "Dingdong" V. Avanzado, adopted Resolution No. SP-1017, Series of 1998, recognizing Quezon City as the "City of Stars":

WHEREAS, as City of Stars, the Quezon City does not only highlight the city as the haven of major Television Studios, Movie Productions Outfits and Recording Companies, but the home of friendly, hospitable, talented, artistic and helpful people. Further, most of the prominent personalities in Philippine movie and entertainment industries are inhabitants of Quezon City;

WHEREAS, it is likewise noteworthy that the local politics of Quezon City has been led, ever since, if not dominated, by movie and entertainment personalities who have succeeded in their chosen field and proved that they can be good leaders and public servants. To name a few, they are: Honorable Alfred Vargas (former Councilor and new a Congressman); Honorables Precious Hipolito-Castalo, Gian Carlo Sotto, Franz S. Pumaren and Jose Andres "Anjo" Ronald Remy Honorables Councilors); (incumbent Yllana S. Angeles (former Vice Mayors); Honorables George Canseco, Consuelo Cielito "Mahal" Del Mundo, Mitchelle Y. Gumabao, a.k.a. Dennis Roldan, Alfredo Francisco, a.k.a. Fred Montilla, Anthony Alonzo, Fernando "Dingdong" Avanzado, Anthony Castelo, Herminio "Butch" Baurista and Aiko Melendez (former City Councilors), Honorables Jigo Garcia and Renato "Gido" Del Prado (former Punong Barangay and Kagawad respectively); Honorable Vicente "Tito" Sotto III (former Vice Mayor and now a Senator); Honorable Francisco "Kiko" Pangilinan (former Councilor and Senator; and, significantly, the former Kabataang Barangay Chairman, former City Councilor and former City Vice Mayor, the incumbent Quezon City Mayor, Honorable Herbert M. Bautista;

WHEREAS, the recognition of being the City of Stars likewise manifests that Quezon City is the city which is rich in culture and a potential hub for business investment and tourism development;

WHEREAS, to instill into the minds of every citizen entering and transacting in Quezon City the value and pride of being a City of Stars and to further boost the morale of city residents, there is a need to install or construct a "Welcome Arch" in major entry points of Quezon City with a statement "Welcome to Quezon City, the City of Stars" to symbolize that all people from all walks of life are warmly accepted in Quezon City.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to request, as it does hereby request the Quezon City Government to facilitate the installation or construction of a "Welcome Arch" in ten (10) major entry points of Quezon City bearing the statement "Welcome to Quezon City, the City of Stars", particularly in the areas described hereunder:

Quirino Highway

(Bounded by Pasong Putik and Kaloocan North)

North)

Area IV : Epifanio Delos Santos Avenue (EDSA)

(Bounded by Unang Sigaw- Balingasa and

Area V : North Diversion Road

(Bounded by Balumbato and Kaloocan South)

Area VI : Mindanao Avenue

(Bounded by Bulacan and Barangay Talipapa)

Area VII : Quezon Avemie

(Bounded by Quezon City and Manila)

Area VIII : Aurora Boulevard

(Bounded by Doña Imelda and San Juan

Area IX : Evifanio Delos Santos Avenue (EDSA)

(Bounded by Quezon City, Mandahayong and

Pasig City)

Area X : Aurora Boulevard

(Bounded by Loyola Heights and Marikina City)
