A RESOLUTION AUTHORIZING THE PURCHASE BY QUEZON CITY GOVERNMENT, THROUGH THE CITY MAYOR, HONORABLE HERBERT M. JUAN INTENDED FOR MONITORING OF PROGRAMS AND PROJECTS UNDER HIS OFFICE.
