BAUTISTA, TO PURCHASE TWO (2) UNITS OF MOTOR VEHICLES INTENDED FOR MONITORING OF PROGRAMS AND PROJECTS OF THE OFFICE OF COUNCILOR RAQUEL S. MALAÑGEN AMOUNTING TO TWO MILLION PESOS (P2,000,000.00) TO BE CHARGED AGAINST THE FUND OF THE OFFICE OF THE CITY COUNCILOR.

WHEREAS, pursuant to Administrative Order No. 1, amending Administrative Order No. 233, Series of 2003, the Honorable City Mayor Herbert M. Bautista has already sought permission and authorization from the DILG in his letter addressed to Mr. Juan Jovian E. Inginiero, CESO IV, City Director of DILG for acquisition of the above-described motor vehicle amounting to P2,000,000.00 which amount is included in the 2014 Annual Budget of the City Government under the City Council, Quezon City;

WHEREAS, pursuant to Section 455 (b) (1) (vi) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance;
