WHEREAS, the City Mayor, Honorable Herbert M. Bautista, issued Executive Order No. 5, Series of 2012, converting the Anti-Poverty Integration Task Force (APITF) into the Quezon City Local Poverty Reduction Action Team (QC-LPRAT) in compliance with DBM-DILG-DSWD-NAPC Joint Memorandum Circular No. 1, Series of 2012 pursuant to Presidential Executive Order No. 43, Series of 2011 mandating the creation of Local Poverty Reduction Action Team (LPRAT) to implement Bottom-Up Planning and Budgeting for Fiscal Year 2013;

WHEREAS, subsequently, on February 21, 2013, the Honorable City Mayor Herbert M. Bautista issued Executive Order No. 5-A, Series of 2013, amending the composition of abovementioned executive order in compliance with the Joint Memorandum Circular No. 3, Series of 2012 of the DBM-DILG-DSWD-NAPC providing policy guidelines and procedures in the implementation of the Bottom-Up Budgeting (BUB) for the FY2014 budget preparation;

WHEREAS, the said Joint Memorandum Circular No. 3, Series of 2012 entered into by DBM-DILG-DSWD-NAPC dated December 20, 2012 provides participating agencies and Local Government Units (LGUs) with the policy guidelines, processes, responsibilities and timeliness in the bottom up budgeting approach to be applied in the preparation of the FY2014 National Expenditure Program; /

WHEREAS, Bottom Up Budgeting (BUB) is an approach to prepare budget proposals of agencies, taking into consideration the development needs of poor cities/municipalities as identified in their respective local poverty action plans that shall be formulated with strong participation of basic sector organizations and other civil society organizations;


WHEREAS, the Quezon City Local Poverty Reduction Action Team (QC-LPRAT) adopted Resolution No. 1, Series of 2013 approving the Quezon City Priority Poverty Reduction Projects of 2013 and endorsing the same to the Department of the Interior and Local Government-National Capital Region (DILG-NCR) as the Regional Poverty Reduction Action Team (RPRAT) Secretariat.

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to adopt, as it does hereby adopt the 2013 Bottom-Up Budgeting (BUB) Priority Poverty Reduction Projects initiated by the Quezon City Local Poverty Reduction Team (QC-LPRAT).

RESOLVED, FURTHER, that the 2013 Bottom-Up Budgeting (BUB) Priority Poverty Reduction Projects of the Quezon City Local Poverty Reduction Team (QC-LPRAT) shall be made an integral part of this Resolution.
