WHEREAS, considering the significant amount of funds that can be saved from payment of annual insurance coverage and renewal of registration, the City General Services Department (CGSD) recommended the transfer without cost and donate these vehicles to all aforementioned barangays and for which the City Mayor favorably considered.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert Constantine M. Bautista, to donate the forty two (42) units of Blaze Tricycle Patrols to the barangay local government units of District IV, Quezon City.

RESOLVED, FURTHER, that ownership of the said Blaze Tricycle Patrols be transferred to the barangay local government units of District IV, Quezon City through the deed of donation to be signed by the City Mayor as DONOR, the barangay Chairperson of the concerned barangay as DONEE, with Mr. Rolando P. Montiel, City Department Head III, City General Services Department and Mr. Jorge P. Felipe, OIC Barangay Operations Center as Witnesses.
