WHEREAS, Phoenix Petroleum Philippines, Inc. (PPPI), a business entity duly registered under Philippine laws is applying for a Special Use Permit (SUP) to be used for the construction and operation of a Gasoline Filling Station located at No. 341 G. Araneta Avenue, Barangay Santol, Quezon City;

WHEREAS, the Sangguniang Barangay of Barangay Santol interposes no objection to the proposed construction because of the benefits and development that would be realized out of the said project and a public consultation with neighboring residents was properly conducted;

WHEREAS, in accordance with the following provisions, particularly Articles III (Section 3), V, VI, and Article IX (Section 18) of the Quezon City Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance and its Implementing Rules and Regulations, a Special Use Permit is required and may be issued on projects falling under the said provisions;
