WHEREAS, petitioner JETTI Petroleum, Inc., a business entity duly registered under Philippine Laws, is applying for a Special Use Permit (SUP) to be used for the construction and operation of a gasoline filling station located at Lot 9 Block 16 Xavierville Avenue, Barangay Loyola Heights, Quezon City;

WHEREAS, the Barangay Council of Barangay Loyola Heights passed Resolution No. 081, Series of 2014, interposing no objection for the construction of a gasoline station to be operated by JETTI Petroleum Inc.;

WHEREAS, fuel stations are among the uses that require Special Use Permit upon authorization from the Quezon City Council pursuant to Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2000;

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the issuance of a Special Use Permit to JETTI Petroleum, Inc. for the construction and operation of a gasoline filling station to be located at Lot 9 Block 16 Xavierville Avenue, Barangay Loyola Heights, Quezon City.
