A RESOLUTION GRANTING A SPECIAL PERMIT TO MR. MIKKO F. CIRUELA, AN ACCREDITED OPERATOR BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR) TO OPERATE AN ELECTRONIC BINGO GAMES AT NO. 848 EPS BUILDING, QUIRINO HIGHWAY, BARANGAY GULOD, NOVALICHES, QUEZON CITY.

WHEREAS, Mr. Mikko F. Ciruela, an accredited operator by the Philippine Amusement and Gaming Corporation (PAGCOR), is applying for a Special Permit from the Quezon City Council as a requirement for the business permit pursuant to Resolution No. SP-3134, S-2005;

WHEREAS, the applicant is authorized to operate an accredited Electronic Bingo Games, through an accredited internet operator, Mr. Mikko F. Ciruela pursuant to, and covered under, the provisions of Presidential Decree No.1869;

WHEREAS, Mr. Mikko F. Ciruela, is applying for a Special Permit to establish, install, maintain and operate an Electronic Bingo at No. 848 EPS Building, Quirino Hi-way Barangay Gulod, Novaliches, Quezon City;

WHEREAS, Mr. Mikko F. Ciruela is entitled to the issuance of a Special Permit in his favor provided that the same has complied with all other requirements provided by existing rules. ✓

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant a Special Permit to Mr. Mikko F. 
RESOLVED, FURTHER, that Mr. Mikko F. Ciruela shall remit to the City Treasury in lieu of all business taxes, a franchise fee of three percent (3%) of the gross revenue which shall be made payable yearly to the City Treasurer during the lifetime of this measure.

RESOLVED, FINALLY, that the authority herein granted shall be only for a period of two (2) years subject to renewal thereafter by the City Council.
