A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT (SUP) TO PHILOS BUILDERS CORPORATION GENERAL CONTRACTOR, FOR THE INSTALLATION AND CONSTRUCTION OF A FORTY (40)-METER HIGH THREE (3) LEGGED SELF-SUPPORTING TOWER, LOCATED AT LOT 1, BLOCK. 3, SITIO MABILOG, BARANGAY CULIAT, TANDANG SORA, QUEZON CITY.

WHEREAS, Philos Builders Corporation General Contractor, an authorized contractor of Hi-Frequency Telecommunications Inc., is applying for a Special Use Permit (SUP) for the construction of a 40-meter high 3 legged self-supporting tower, located at Lot 1, Block 3, Sitio Mabilog, Barangay Culiat, Tandang Sora, Quezon City;

WHEREAS, pursuant to the provision of Article VII, Section 2. (D)(2) of Ordinance No. SP-918, S-2000, as amended, otherwise known as the Quezon City Comprehensive Zoning Ordinance where the public welfare demands, however, radio transmitting stations maybe located in some residential zones provided that certain conditions are complied with strictly, and no interference with or damage to local electrical appliances or other property will likely result;


WHEREAS, Barangay Culiat issued a certification/ clearance granting the proposed installation and construction of the said tower last May 2014 as the said barangay interposes no objection to the said project;

WHEREAS, applicant has complied with the requirements for their application for the issuance of a Special Use Permit and Barangay Culiat and the residents therein interpose no objection as provided in their Barangay Resolution No. 100, S-2014 adopted last September 17, 2014.


NOW, THEREFORE,


