A RESOLUTION DESIGNATING ATTY. ALBERTO C AGRA AS AMICUS LOCI IMPERIUM OR PRO BONO COUNSEL OF THE QUEZON CITY GOVERNMENT CONCERNING THE ASSAILED ORDINANCE NO. SP-2301, SERIES OF 2014 THE SUBJECT OF A CASE PENDING BEFORE THE SUPREME COURT DOCKETED AS G.R. NO. 225442.

WHEREAS, the Quezon City Government (QCG) is impleaded as one of the Respondents in the Petition for Certiorari and Prohibition (with an urgent application for a Temporary Restraining Order), filed by the Samahan ng mga Progresibong Kabataan (SPARK), represented by Joanne Rose Sace Lim, John Arvin Navarro Buenaagua, Ronel Baccutan, Marl Leo

Delos Reyes and Clarissa Joyce Villegas, minor, for herself as represented by her father Julian Villegas, Jr. vs. Quezon City, as represented by Mayor Herbert M Bautista, City of Manila as represented by Mayor Joseph E Estrada and Navotas City, as represented by Mayor John Rey Tiangco (G.R. No. 225442);

WHEREAS, the Quezon City, in order to address all constitutional and legal issues raised in the Petition for Certiorari and Prohibition (with an urgent application for a Temporary Restraining Order), which assails the power of the Local Government Units, to impose a curfew and protect the general welfare of the community, seeks to obtain the services of an expert on Public Corporations, at NO COST to the City;


WHEREAS, Atty. Alberto C Agra is a Political Law Bar Reviewer and a Professor of Law teaching Administrative Law, Law on Public Corporation, Law on Public Officers, Election Law and Law on Public-Private Partnership (PPP) at the Ateneo de Manila Law School. He has been teaching since 1993 and authored several publications on Local Government, to wit: Case Law on Local Autonomy and Local Governance: A survey of Supreme Court Decisions from 1901 to June 30, 2010; Compendium of Decisions, Rulings, Resolutions and Opinions on Local Autonomy and Local Government (1996); and Local Government Discourse – Series of Questions and Answers on Local Government concerns. He will soon publish Amicus Loci Imperia (Friend of Local Governments), which contains a Reviewer on Local Government Law, the 1991 Local Government Code, it's Implementing Rules and Regulations and Opinions of the Department of Interior and Local Government (DILG) from 1992 to May 2016, and Compendium of Supreme Court Cases on local Autonomy and Local Governments from 1900 to May 2016. λ


