A RESOLUTION AMENDING RESOLUTION NO. SP-5817, S-2013, TO INCLUDE IN THE DISPOSITIVE PORTION THE PEOPLE'S CONSULTATIVE COUNCIL (PCC) EAST AND NATIONAL GOVERNMENT CENTER HOUSING AND DEVELOPMENT PROJECT (NGCHDP) EAST, AS IT WAS INADVERTENTLY OMITTED.

WHEREAS, on December 2, 2013, the City Council of Quezon City adopted Resolution No. SP-5817, S-2013, entitled "A Resolution Authorizing the City Mayor, Honorable Herbert M. Bautista to enter into a Memorandum of Agreement, for and in behalf of the Quezon City Government, with the National Housing Authority, National Government Center Housing and Development Project, represented by Atty. Chito M. Cruz, General Manager, for the utilization of the 2<sup>nd</sup> and 3<sup>rd</sup> Tranche of the Financial Assistance given yearly in the amount of Sixty Nine Million Pesos (P69,000,000.00) under the funds of the Quezon City Government covering Fiscal Years 2012 and 2013";

WHEREAS, in the dispositive portion of the said Resolution, the following have been inadvertently omitted, viz;

1. In paragraph 3, it should be read as: 1.0 Honoraria and Allowances of PCC-West and East, and X xx...

*RESOLVED, FURTHERMORE, that the Forty Eight Million Pesos (P48,000,000.00) of the total amount shall serve as revolving fund to be used by the NGCHDP-West and East Project x xx.. and*

*RESOLVED, FINALLY, to furnish the NHA, NGC, PCC-West and East and x xx..*

*WHEREAS, there is a need to amend the aforesaid Resolution in order to correct and to serve its true intent.*


*NOW, THEREFORE,*


