RESOLUTION NO. SP. 6883 S-2016

A RESOLUTION ENDORSING THE NOMINEES FROM THE PRIVATE SECTOR WHO ARE BONA FIDE RESIDENTS OF QUEZON CITY TO THE QUEZON CITY DEVELOPMENT AUTHORITY (QCDA) BOARD OF DIRECTORS.

Introduced by Councilor GODOFREDO T LIBAN II.

WHEREAS, the Quezon City Development Authority (QCDA) was created by virtue of Republic Act No. 10646 and primarily focuses on the development of socialized housing and urban renewal in Quezon City;

WHEREAS, pursuant to its Charter, the QCDA Board of Directors shall be composed of, among others, four (4) representatives from the private sector who are all bona fide residents of Quezon City;

WHEREAS, the City Mayor and the Sangguniang Panlungsod must recommend at least three (3) names for every vacant position representing the private sector.
