FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE FILLING STATION LOCATED AT LOT 1, BLOCK 117, TACIO STREET, BARANGAY PAANG BUNDOK, QUEZON CITY IN ACCORDANCE WITH THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE NO. SP-918, S-2000, AS AMENDED.

WHEREAS, G'Little Trading Inc., a business entity duly registered under Philippine laws, is applying for a Special Use Permit (SUP) to be used for the construction and operation of a Gasoline Filling Station located at Lot 1, Block 117, Tacio Street, Barangay Paang Bundok, Quezon City;

WHEREAS, the Sangguniang Barangay of Barangay Paang Bundok and the residents therein interposed no objection to the proposed construction because of the benefits and development that would be realized out of the said project and a public consultation with neighboring residents was properly conducted;

WHEREAS, the construction and operation of a gas station will provide local employment within the vicinity and promote economic development in the Barangay as well as the City;



WHEREAS, the owner of the proposed gasoline station has complied with the requirements for the issuance of a Special Use Permit as required by said Ordinance.


NOW, THEREFORE,


