A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT (QCG), THROUGH MAYOR HERBERT M. BAUTISTA, TO ENTER INTO CONTRACT/S OF AGREEMENT WITH THE WINNING BIDDERS AND/OR CONTRACTORS OF THE VARIOUS INFRASTRUCTURE PROJECTS OF THE QUEZON CITY GOVERNMENT, SUBJECT TO EXISTING LAWS RULES AND REGULATIONS.


