A RESOLUTION URGING THE DEPARTMENT OF TRANSPORTATION (DOTr), THROUGH ITS ROAD TRANSPORT PLANNING DIVISION, TO CONSULT WITH THE LOCAL GOVERNMENT UNITS (LGUs) IN THE DETERMINATION OF THE ROUTE MEASURED CAPACITY (RMC) FOR PUBLIC UTILITY VEHICLES (PUVs).

WHEREAS, the Department of Transportation (DOTr), through its Road Transport Planning Division, determines the number of public transport vehicles serving a particular route using a Route Measured Capacity (RMC) formula;

WHEREAS, Route Measured Capacity (RMC) is defined as the number of trips to efficiently meet the passenger's demand which were applied to buses, jeepneys and UV Express vehicles;

WHEREAS, it is high time that Local Government Units (LGUs) should be consulted in the determination of the Route Measured Capacity (RMC) by the Department of Transportation, through its Road Transport Planning Division, because they can identify which routes are over-served or under-served;


WHEREAS, the Local Government units may encourage the different sectors to participate in public consultations to gather information to come up with a rationalized and a comprehensive routes for the benefit of the riding public;

WHEREAS, to efficiently address the transport needs in different localities, the assistance of the Local Government Units (LGUs) should be utilized in the determination of the Route Measured Capacity (RMC) for Public Utility Vehicles (PUVs).

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge the Department of Transportation (DOTr), through its Road Transport Planning Division, to consult with the Local Government Units (LGUs) in the determination of the Route Measured Capacity (RMC) for Public Utility Vehicles (PUVs).


