A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT (QCG) THROUGH, THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO GRANT FINANCIAL ASSISTANCE IN THE AMOUNT OF ONE MILLION PESOS (P1,000,000.00) TO THE ENVIRONMENTAL MANAGEMENT BUREAU (EMB), FOR THE CELEBRATION OF THE "ZERO-WASTE MONTH" ON JANUARY 2017, SUBJECT TO EXISTING ACCOUNTING AND AUDITING, RULES AND REGULATIONS.

WHEREAS, under Republic Act No. 7160, otherwise known as the Local Government Code of 1991, specifically Section 23. Authority to Negotiate and Secure Grants.- The Local Chief Executive may, upon the authority of the Sanggunian, negotiate and secure financial grants or donations in kind, in support of the basic services facilities enumerated under Section 17 hereof, from local

and foreign assistance agencies without the necessity of securing clearance or approval thereof from any department, agency or office of the national government or higher local government unit, xxx;

WHEREAS, on May 15, 2014, former President Benigno S. Aquino III signed Proclamation No. 760, declaring the month of January (and every year thereafter) as the "Zero-Waste Month";

WHEREAS, the celebration of "Zero-Waste Month"; on January 2017, will also mark the anniversary of Republic Act No. 9003, otherwise known as the "Ecological Solid Waste Management Act of 2000";

WHEREAS, coinciding with the celebration of "ZERO-WASTE month" there will be an Environmental Summit and Exhibition, to be held on January 26-29 at the Quezon City Memorial Circle, sponsored by the Environmental Management Bureau (EMB) in partnership with other National Government Agencies, Non-Governmental and People's Organizations as well as other Local Government Units;

WHEREAS, the Environmental Summit and Exhibition will feature conferences, seminars, workshops, demonstrations, exhibits, fairs, concerts and other various activities identified and planned by the steering committee;

WHEREAS, it is a form of good governance to utilize the resources and/or funds of the City as efficiently and as effectively as possible to finance the delivery of basic services and the enhancement of various social and economic activities for the prosperity and progress;


WHEREAS, Honorable Herbert M. Bautista, in his capacity as Mayor, acceded to assist in the celebration of the environmental Summit and Exhibition in fulfilling its aim, "to create awareness about environmental protection and help improve solid waste management", by donating the amount of One Million Pesos (Php1,000,000.00). ↕
