A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO "PETRON CORPORATION" FOR THE CONSTRUCTION OF CANOPY EXPANSION, INCLUDING TWO (2) DISPENSING PUMPS, AND OPERATION OF A GASOLINE REFILLING STATION LOCATED AT LOT 3 BLOCK 3 COMMONWEALTH AVENUE, BARANGAY FAIRVIEW, QUEZON CITY.

WHEREAS, petitioner "Petron Corporation", a business entity duly registered under Philippine Laws, is applying for a Special Use Permit (SUP) to be used for the construction of canopy expansion, including two (2) dispensing pumps, and operation of a gasoline refilling station located at Lot 3 Block 3 Commonwealth Avenue, Barangay Fairview, Quezon City;

WHEREAS, fuel stations are among the uses that require Special Use Permit upon authorization from the Quezon City Council pursuant to the Quezon City Comprehensive Zoning Ordinance; Res. No. SP- 7008, S-2017 Page -2- PR20CC-227

WHEREAS, "Petron Corporation" has complied with the necessary requirements for the issuance of a Special Use Permit as mandated by the aforementioned Quezon City Comprehensive Zoning Ordinance;

WHEREAS, the construction, installation and operation of a gas station will provide employment and promote economic development in the City.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the issuance of a Special Use Permit to "Petron Corporation" for the construction of canopy expansion, including two (2) dispensing pumps, and operation of a gasoline refilling station located at Lot 3 Block 3 Commonwealth Avenue, Barangay Fairview, Quezon City.
