**A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO "PETRON CORPORATION" FOR THE CONSTRUCTION OF CANOPY EXPANSION, INCLUDING TWO (2) DISPENSING PUMPS, AND OPERATION OF A GASOLINE REFILLING STATION LOCATED AT LOT 3 BLOCK 3 COMMONWEALTH AVENUE, BARANGAY FAIRVIEW, QUEZON CITY.**

*WHEREAS, petitioner "Petron Corporation", a business entity duly registered under Philippine Laws, is applying for a Special Use Permit (SUP) to be used for the construction of canopy expansion, including two (2) dispensing pumps, and operation of a gasoline refilling station located at Lot 3 Block 3 Commonwealth Avenue, Barangay Fairview, Quezon City;*

*WHEREAS, fuel stations are among the uses that require Special Use Permit upon authorization from the Quezon City Council pursuant to the Quezon City Comprehensive Zoning Ordinance;*

WHEREAS, "Petron Corporation" has complied with the necessary requirements for the issuance of a Special Use Permit as mandated by the aforementioned Quezon City Comprehensive Zoning Ordinance;

WHEREAS, the construction, installation and operation of a gas station will provide employment and promote economic development in the City.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the issuance of a Special Use Permit to "Petron Corporation" for the construction of canopy expansion, including two (2) dispensing pumps, and operation of a gasoline refilling station located at Lot 3 Block 3 Commonwealth Avenue, Barangay Fairview, Quezon City.


