A RESOLUTION RENEWING THE SPECIAL PERMIT OF "PAYLINE INCORPORATED" TO OPERATE AN ELECTRONIC BINGO OR E-BINGO AT THE GROUND FLOOR OF ALI MALL, ARANETA CENTER, CUBAO, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).

WHEREAS, "Payline Incorporated", a domestic corporation duly organized and existing under and by virtue of Philippine laws, represented by its President, Mr. Justin Gotianse, with principal office address at the Ground Floor of Ali Mall, Araneta Center, Cubao, Quezon City, is applying for the Renewal of its Special Permit to operate an Electronic Bingo or E-Bingo;

WHEREAS, sometime in 2013 the City Council passed a Resolution granting a Special Permit to the applicant to operate the said Electronic Bingo docketed as Resolution No. SP-5693, S-2013; 22nd Regular Session

WHEREAS, to enable "Payline Incorporated" to continue its legal business operation, there is a need to renew their Special Permit;

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, in relation to existing city ordinances, authorizes the City Council to grant special permit to business activity of the same nature.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to renew, as it does hereby renew, the Special Permit of "Payline Incorporated" to operate an Electronic Bingo or E-Bingo at the Ground Floor of Ali Mall, Araneta Center, Cubao, Quezon City, subject to the Rules and Regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED, FURTHER, that the authority to operate Electronic Bingo or E-Bingo granted to herein applicant shall be subject to the following conditions:

- a. The holding of Electronic Bingo or E-Bingo shall be in accordance with the Rules and Regulations promulgated by PAGCOR;
- b. The operation of Electronic Bingo or E-Bingo shall not include the playing of games not related to or other than bingo;
- c. The operator is enjoined to prohibit individuals below eighteen (18) years of age from playing in the above-mentioned games.

RESOLVED, FURTHERMORE, that "Payline Incorporated" shall remit a franchise fee of three percent (3%) of the gross sales of herein grantee which shall be made payable yearly to the City Treasurer's Office during the lifetime of this measure.

RESOLVED, FINALLY, that this Special Permit to operate an Electronic Bingo or E-Bingo shall be for a period of three (3) years and maybe renewed.
