WHEREAS, "Movie Workers Welfare Foundation, Inc." (MOWELFUND) is a non-stock, non-profit corporation, organized and established in 1974 by virtue of the laws of the Republic of the Philippines with principal address at No. 66 Rosario Drive corner llang-llang Street, Barangay Immaculate Conception, Cubao, Quezon City;

WHEREAS, MOWELFUND, Inc. submitted its application for renewal of accreditation on December 7, 2016 with the Community Relations Office (CRO);

WHEREAS, on February 09, 2016, the Office of the City Mayor through City Administrator Aldrin C. Cuña, MNSA, informed the said organization through a letter addressed to its President/Trustee Ms. Boots Anson Roa-Rodrigo that the Office of the City Mayor has granted the amount of Five Hundred Thousand Pesos (Php500,000.00) as financial assistance after submitting the necessary requirements, to wit:

- 1. Accreditation from the Community Relations Office(CRO)
- 2. SEC Registration
- 3. Audited Financial Statement
- 4. Resolution from the City Council granting assistance pursuant to Section 36 of RA 7160, as amended
- Memorandum of Agreement
- б. Mayor's permit;

WHEREAS, Section 36 of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991" expressly provides:

"Section 36. Assistance to People's and Nongovernmental Organizations. - A local government unit may, through its local chief executive and with the concurrence of the sanggunian concerned, provide assistance, financial or otherwise, to such people's and non-governmental organizations for economic, sociallyoriented, environmental, or cultural projects to be implemented within its territorial jurisdiction."

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to grant financial assistance in the amount of Five Hundred
