WHEREAS, former Sangguniang Panlungsod Member, Herminio C. Bautista, popularly known as "Butch", who had faithfully served Quezon City in various capacities, died on February 12, 2017 at the age of eight two (82) years old;

WHEREAS, the late Herminio "Butch" Bautista was born on November 12, 1936 to Graciano V. Bautista and Iladiadela Cruz and spent most of his life in this City. From humble beginnings, he successfully carved a name for himself through hard work and dedication as an exemplary public servant;

WHEREAS, he finished his liberal arts education at the University of Santo Tomas (UST) in 1957. Even when his formal education was not yet finished, he was already working as an actor at the age of seventeen (17);

WHEREAS, the late Herminio "Butch" Bautista, a loving family man, is the father of Quezon City Mayor Herbert M. Bautista and District 4 Councilor Hero Clarence M. Bautista;

WHEREAS, before he became a Member of the Sangguniang Panlungsod, he was known as the youngest movie director in Philippine cinema at the age of nineteen (19);

WHEREAS, he was also a former Punong Barangay of Barangay Immaculate Conception from 1982-1987. In 1986, he was President of the Kapisanan ng mga Direktor ng Pelikulang Pilipino, Member of the Board of Governors of the Film Academy, former President of Rotary Club, Cubao West, and honorary member of the Screenwriters Guild of the Philippines;

WHEREAS, the late Herminio "Butch" Bautista, was elected Councilor of the Fourth District for two consecutive terms from 1988 to 1995, and among his many accomplishments is an Ordinance Creating the Motorpool Division under the City General Services Office and Ordinance granting incentive bonus to all Barangay Officials in Quezon City and incentive pay to city government personnel;

WHEREAS, he chaired the City Council Committee on Appropriations where he passed measures that appropriated funds for the operation of 24-hour health centers in the City, and providing free funeral services/assistance to all four (4) districts in Quezon City;

WHEREAS, the Quezon City, its officials and residents, mourn his passing away and convey their condolences and heartfelt sympathies to his family, with deepest gratitude for his work and legacy as one of the city's inspiring leaders.
