RESOLUTION NO. SP- **7041**, S-2017

A RESOLUTION AMENDING RESOLUTION NO. SP-6575, S-2015, "A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO EXTEND FINANCIAL ASSISTANCE IN BEHALF OF THE QUEZON CITY GOVERNMENT IN THE AMOUNT OF THIRTY THREE MILLION FIVE HUNDRED FIFTY SEVEN THOUSAND PESOS (PHP 33,557,000.00) TO THE MUNICIPALITIES IN REGIONS II AND III OF NORTHERN LUZON SEVERELY AFFECTED BY TYPHOON LANDO (KOPPU) NAMELY: SAN MIGUEL, BULACAN; BALER, AURORA; AND BAMBANG, NUEVA VIZCAYA, TO BE TAKEN FROM THE QUEZON CITY DISASTER RISK REDUCTION AND MANAGEMENT FUND", THEREBY CHANGING THE ORIGINAL AMOUNT TO THIRTY TWO MILLION THIRTY EIGHT THOUSAND SEVEN HUNDRED TWELVE PESOS AND NINETY CENTAVOS (PHP32,038,712.90), AS WELL AS ITS INTENDED USE.

WHEREAS, on December 7, 2015, the Quezon City Council through Resolution No. SP-6575, S-2015 has authorized the Honorable Mayor to extend financial assistance on behalf of the Quezon City Government to the identified typhoon Lando worst hit municipalities of San Miguel, Bulacan; Baler, Aurora; and Bambang, Nueva Vizcaya; A

WHEREAS, the following was specifically specified in the said resolution:

Baler, Aurora	Php1,600,000.00	Agricultural assistance such as seeds & fertilizer, fishing boats for livelihood, infrastructure rehabilitation
Bambang, Nueva Vizcaya	Php3,846,000.00	Rehabilitation of irrigation system, provision of rescue equipment and other tools
TOTAL	Php33,557,000.00	

WHEREAS, after careful study of the Quezon City Disaster Risk Reduction and Management Council (QCDRRMC), it has been determined that revisions to the original plan were necessary and appropriate to fully benefit the recipient municipalities of the city funds;

WHEREAS, in line with the aim of lending a helping hand and alleviating the lives of the people who were affected by typhoon Lando, the following are the amendments made to Resolution No. SP-6575, S-2015;

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to amend, as it does hereby amend Resolution No. SP-6575, S-2015, "A Resolution authorizing the City Mayor, Honorable Herbert M. Bautista, to extend financial assistance in behalf of the Quezon City Government in the amount of Thirty Three Million Five Hundred Fifty Seven Thousand Pesos (Php 33,557,000.00) to the Municipalities in Regions II and III of Northern Luzon severely affected by typhoon Lando (Koppu) namely: San Miguel, Bulacan; Baler, Aurora; and Bambang, Nueva Vizcaya, to be taken from the Quezon City Disaster Risk Reduction and Management Fund", thereby changing the original amount to Thirty Two Million Thirty Eight Thousand Seven Hundred Twelve Pesos and Ninety Centavos (Php32,038,712.90), as well as its intended use.

RESOLVED, FURTHER, that copy of this Resolution be furnished to the Office of the City Mayor, the Quezon City Disaster Risk Reduction and Management Council (QCDRRMC), and the Municipalities of San Miguel, Bulacan, Baler, Aurora and Bambang, Nueva Vizcaya.


