A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO SIGN THE DEED OF DONATION IN FAVOR OF BARANGAY PROJECT 6, DISTRICT 1, QUEZON CITY, FOR THE DONATION OF TEN (10) UNITS OF CCTV SYSTEM AS PART OF THE QUEZON CITY GOVERNMENT'S CRIME PREVENTION PROGRAM, AND AUTHORIZING THE TRANSFER OF OWNERSHIP OF THE SAID UNITS TO THE RECIPIENT WITHOUT COST.

WHEREAS, as part of the crime prevention and protection program of Quezon City, ten (10) units of CCTV system will be purchased through the funds of the Office of Councilor Elizabeth A. Delarmente;

WHEREAS, the CCTV system would be utilized as a first line of defense in the community to address and suppress criminal activities proliferating in the said barangay;


WHEREAS, it is but proper to turn over the ownership of the CCTV system to the recipient so that these city-owned properties may be transferred without cost;

WHEREAS, a Deed of Donation will be executed and entered into with the recipient barangay to convey and cede the ownership of said CCTV system with the City assuming all fees and dues therein.


NOW, THEREFORE,


